WOODLAWN'S FINANCIAL OBLIGATIONS, INCLUDING NYS LAW

This year, the Woodlawn Board felt it was time to make our donors aware of some important facts that perhaps have not been emphasized enough in the past. First, we mail out approximately 250 donation appeal letters each Spring and Fall. We typically receive donations from about 30% of our potential donors. Ever rising costs of salaries, NYS mandated programs, equipment, fuel, etc. make our ability to meet financial obligations unsustainable at this level of donor assistance.

Secondly, our total barebones expense budget for 2024 is estimated at \$52,000, with only \$20,000 of that amount projected in donations. Our other sources of income (permanent maintenance fund interest, lot sales, and interment fees) only generate another \$16,000. Therefore, we will need to generate an extra \$16,000 in order to adequately cover our expenses. With that being said, \$52,000 would only cover the absolute necessities for operating this year, leaving us without any "extra" money in case some costly, unforeseen issue arises that needs to be addressed.

Lastly, if at any point we were unable to meet our financial obligations, the Woodlawn Board would be required to relinquish the cemetery per New York State Cemetery law, at which point the Town of Hamilton would be required to assume responsibility for Woodlawn. However, they would only be required to mow the cemetery 3 times per season and would not be obligated to sell any remaining lots. The Woodlawn Board is committed to avoiding this situation.

Please give some thought toward the possibility of increasing your donation gift this year, by however much you can, to help us increase our income and cover expenses, as well as having a little extra for expenses we can't foresee. Increased generosity from all our potential donors will make this a reality, preserving our cemetery as the beautiful forever home where your loved ones reside.
